Students aged 17 or under may receive one-on-one training with an instructor if such training is agreed to by the parent or guardian. The student is required to meet the observation requirements with at least one other student in the road evaluation.

Normally, there are two students in the car each driving and observing a 50-minute session. With parental permission, a third student can join during the last observation period. The third student would observe for 50 minutes and then the original two students would be dismissed. The third student would remain with the instructor and drive for 50 minutes. This road evaluation option is helpful for students with time constraints due to school, school athletics, school extracurricular activities, travel, or work. When there are long waiting lists, an instructor can drive with three students after school instead of two. Parents should only sign permission if they want their child to have this option.
